## TERMS AND CONDITIONS, WAIVER AND RELEASE OF LIABILITY

**Important Travel Information** I acknowledge and agree that it is my responsibility to make my own travel inquiries regarding my trip, including any relevant government travel safety warnings.

**Passport** I acknowledge that I must have a passport valid for six months past the expected end date of my Mary Magdalene Pilgrimage.

**Vaccinations** I acknowledge and agree that it is my responsibility to consult my personal physician, any local public health resources as well as the requirements for the country we are visiting. Required inoculations, if any, must be recorded by my health practitioner on a valid vaccination certificate which I must carry for proof of inoculation where required.

**Health/Fitness Level** Trip participants should be healthy and active. By making the nonrefundable deposit, the trip participant certifies that she does not have any physical condition(s) and/or disability (ies) that could create a hazard for the trip participant or any other participants of the Pilgrimage. The Pilgrimage requires a moderate level of fitness and mobility. Furthermore, the trip participant is responsible for retrieving and maintaining her luggage throughout the Pilgrimage.

**Travel Insurance.** I acknowledge that I am urged to arrange comprehensive travel insurance to cover any unforeseen circumstances that may occur during or before the Mary Magdalene Pilgrimage. The Comtac Corporation is not liable in any regard for my failure to insure myself adequately, and I agree to indemnify and hold The Comtac Corporation harmless for any expenses or delays incurred because of my failure insure myself adequately.

**Mary Magdalene Pilgrimage Price.** The "Mary Magdalene Pilgrimage Price" is the total amount listed on my invoice. All Mary Magdalene Pilgrimage Prices are quoted in U.S. Dollars. Payments in Canadian and British options are available and will be noted on your invoice.

- Items included in my Mary Magdalene Pilgrimage Price are expressly listed on the Itinerary.
- Items not included in my Mary Magdalene Pilgrimage Price are listed on the itinerary.

**Booking Deposit.** We require a firm commitment from 6 participants in order to finalize our journey. Your deposit of \$1500 USD will be refundable until we have received confirmations from 6 participants. I acknowledge that I agree that my deposit will be held in trust until 6 are confirmed and that after that point the amount will be non-refundable. You will receive confirmation by email once your deposit is non-refundable.

**Payment Options** When making your deposit you will have an option to pay the balance in full or to split the balance into two equal payments. Split payments will be 50% of the balance due by May 31<sup>st</sup>, 2025. with the final payment due July 31, 2025

### Cancellations and Refunds

- Your deposit of \$1,500 secures your place on the tour and is non-refundable after we have 6 received.
- Cancellations before July 31<sup>st</sup>, 2025 have a 50 percent refund after a \$500 USD cancellation fee is deducted
- Cancellations after July 31, 2025 have no refund. Transferable with a \$500 USD fee
- Payments less non refundable deposit and any cancellation fees can be transferred to another participant on approval from admin.
